

# HIS LIFE MATTERED

Global protests have emerged in the U.S.A. after the death of an African American man in police **custody\***.

George Floyd, 46, was arrested in Minneapolis, Minnesota on 25 May on suspicion of passing fake money. During his arrest, a police officer knelt on his neck for more than eight minutes. Mr Floyd protested that he couldn't breathe.

Videos of the incident provoked protests across the country. The police officer, Derek Chauvin, has been accused of third-degree murder and three other police officers have been **dismissed\***.



## “I Can't Breathe”

Floyd's **plea\*** that he was being asphyxiated was an echo to another **case\***. In 2014, in Staten Island, New York, Eric Garner was strangled by a police officer after protesting 11 times that he couldn't breathe. The incident started Black Lives Matter protests in the USA. The officer responsible was never **charged\***, but he was dismissed from the NYPD (New York Police Department) in 2019.

Protesters about the George Floyd murder use the slogan and hashtag “*I can't breathe*” in demonstrations.
